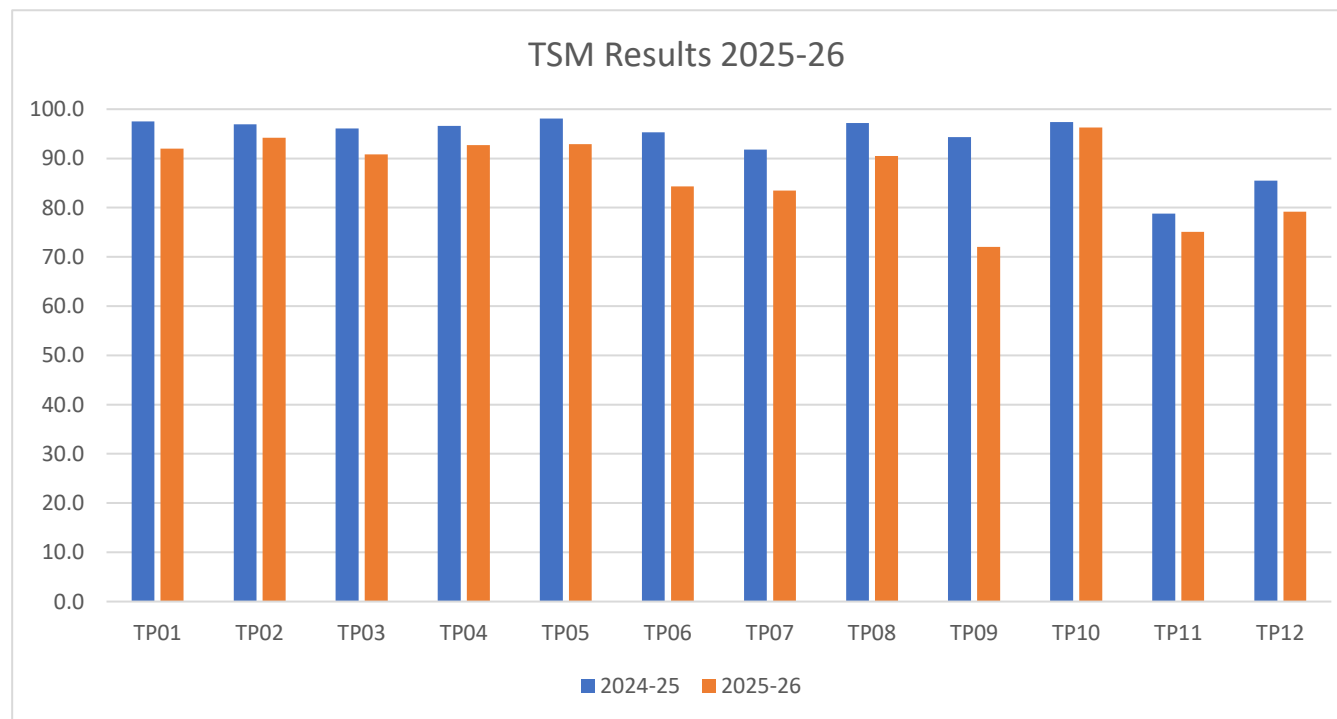


Tenant Satisfaction Measures 2025-26

The 2025–26 Tenant Satisfaction Measures (TSMs) indicate that, while overall satisfaction with Sustain UK’s services remains high, there has been a consistent reduction across most perception-based measures compared to 2024–25. Overall satisfaction (TP01) stands at 92.0%, representing a decrease of 5.5 percentage points year-on-year, with similar downward trends observed across repairs, safety, communication, and tenant engagement measures. This pattern aligns with wider sector insights, where tenant satisfaction remains generally positive but comparatively lower scores are consistently seen in areas such as communication, engagement, and complaints handling. It also reflects the increasing maturity of TSM reporting, with tenants providing more candid and experience-based feedback on landlord services.
